**TITLE: AUTHORIZING CAPITAL PURCHASE OF LEAF LOADER**

**WHEREAS**, the DPW is in need of a new Trailer Leaf Loader; and

**WHEREAS**, the purchase was included in the 2024 Capital Budget pursuant to ordinance no. 1148-24; and

**WHEREAS**, the Public Works Manager has researched vendors that would achieve the Borough's goals and determined that the John Deere ODB LCT650 model may be procured through Sourcewell, a nationally recognized and accepted cooperative purchasing; and

**WHEREAS**, the Borough of Demarest is a member (number #27871) with Sourcewell; and

**WHEREAS**, the Public Works Manager has provided a quote dated September 3, 2024 per Sourcewell Contract #031121-ODB for the equipment with Timmerman Equipment Company in Whitehouse, NJ; and

**WHEREAS**, pursuant to N.J.S.A. 52: 34-6. 2b. (3) ( as amended by P.L. 2011, c. 139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

**WHEREAS**, the nature of the described purchase was published on October 15, 2024 with a 10-day comment period as required by LFN 2021-10; and

**WHEREAS**, also pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011, c. 139) and LFN 2012-10, prior to making purchases under nationally recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

**WHEREAS**, the Borough Purchasing Agent and Public Works Manager have determined that the Borough's use of the Sourcewell cooperative purchasing contract to procure the equipment will result in cost savings to the Borough; and

**WHEREAS**, the CFO has certified that funds are available in account no. C-04-2150-55-106-5013;  
and

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Borough of Demarest that the CFO is authorized to purchase a new equipment for the DPW for \$98,691.54






