TITLE: RESOLUTION OF THE BOROUGH OF DEMAREST, COUNTY OF BERGEN, STATE OF NEW JERSEY AUTHORIZING CERTAIN STATUTORY PAYMENTS OF CLAIMS AND OTHER CLAIMS REGULAR IN NATURE

WHEREAS, all claims of payment by the Borough of Demarest, County of Bergen, State of New Jersey, are required to be first submitted to the Borough of Demarest Governing Body for consideration before payment, and

WHERE AS, due to the nature of certain claims and timing of the particular meeting involved, certain claims should be paid when presented which are statutory and regular in nature, rather than held for the next council meeting of the Borough of Demarest due to the nature of said claims.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Demarest, as follows:

- 1) The Brough of Demarest does hereby approve the payment between meeting of the following encumbered claims for payment, when the same are presented to the Borough of Demarest Council and Chief Financial Officer of the Borough of Demarest.
 - a) Borough of Demarest payroll obligations
 - b) Borough of Demarest required payments to the Board of Education
 - c) Required County Tax payments to the County Treasurer
 - d) Debt Service obligations
 - e) Federal, State and County fees

- f) Utilities (electric/gas, water and telephone)
 - g) Health, Dental and other Insurance premiums
 - h) Reissue of lost or mutilated checks after stop payment has been enforced
 - i) Miscellaneous disbursements approved by specific resolutions
 - j) Postage for tax bills, newsletter and other Borough mailings
 - k) Items deemed necessary for Pre-Payment by the Chief Financial Officer conditioned upon consent of the Administrator, and Finance Committee chair.
- 2) The Chief Financial Officer is hereby authorized and directed to prepare the proper vouchers for payment of the above recited accounts when same is properly presented to her for payment, and thereafter said claim shall be transcribed on the next scheduled Bills list to be approved by the Borough of Demarest Council
- 3) A certified copy of this resolution shall be forward to the Chief Financial Officer of the Borough of Demarest

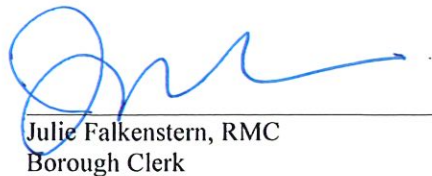
