APPOINTMENT OF THE 2025 PLANNING BOARD PLANNER

WHEREAS, the Borough of Demarest Planning Board (Board) is in need of professional Planning services; and

WHEREAS, Darlene Green, PP, AICP of Colliers Engineering and Design, 53 Frontage Road, Suite 110, Hampton, NJ 08827. has submitted a proposal to perform such services; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 *et seq.*) authorizes the award of a professional services contract for such services without competitive bidding by reason that such services constitute "professional services" which are services rendered or performed by a person authorized by law to practice a recognized profession, whose practice is regulated by law and the performance of which services requires knowledge of an advanced type in a field of learning acquired by a prolonged formal course of specialized instruction and study as distinguished from general academic instruction or apprenticeship; and

WHEREAS, the Board finds that it would be in the best interests of the Borough of Demarest Planning Board to award a contract for such services to Darlene Green, PP, AICP of Colliers Engineering and Design, based on their experience pursuant to N.J.S.A. 19:44A-20.5 as a "Fair and Open" contract as defined therein; and

WHEREAS, the aforesaid contract shall be subject to adequate funds therefor pursuant to the 2025 Temporary Budget and 2025 Budget of the Borough of Demarest;


NOW, THEREFORE BE IT RESOLVED, by the Board of the Borough of Demarest Planning Board that Darlene Green, PP, AICP of Colliers Engineering and Design, be retained to provide professional planning services for the Borough of Demarest Planning Board for a term commencing January 1, 2025, for 1 year or until a successor is appointed, and that the Board Chairman is hereby authorized to execute, and the Board Secretary to attest, an


Agreement to carry out the foregoing, a copy of which is on file in the Office of the Board Secretary and Borough Clerk and is available for public inspection, subject to the approval thereof by the Mayor and Council of the Borough of Demarest; and

BE IT FURTHER RESOLVED that Darlene Green, PP, AICP of Colliers Engineering and Design, be required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27; and

BE IT FURTHER RESOLVED that the Board Secretary is hereby authorized and directed to cause a notice to be published in the manner provided by law setting forth the nature, duration, service and amount of the Agreement and that the resolution and Agreement are on file in the Office of the Board Secretary and Borough Clerk and are available for public inspection.
