Pursuant to the requirements of law, the accompanying plan or drawing and specifications for the plumbing and drainage of the above mentioned building, which are made a part hereof, are hereby submitted for approval by the Borough Engineer; the undersigned hereby agreeing to cause the work to be done and the materials to be furnished in accordance therewith with such modifications as may be required by the Department of Public Works or the Board of Health. The applicant agrees to replace at his own cost and expense, the street, curb, gutter and sidewalk in the same state and condition in all things as they were at the time of commencement of the work within 48 hours of the commencement of same. **All excavations must be backfilled with crushed stone, preferably quarry process.** No modifications of the plan or drawing and specification of the work mentioned therein will be made unless the same is previously allowed by the Board or Department in writing upon the written application of the owner or architect made therefore; and all work pertaining to the proper plumbing and drainage of said building and premises which is not covered by the plan or drawing and specification by is found necessary during the progress of the same in order to carry into effect the true intent thereof, will be executed in accordance with the directions of the Borough Engineer, and all work must adhere to Chapter 150, which are the Revised General Ordinances of the Borough of Demarest and other Federal State and County Rules and regulations.
