Health Inspector's Report

Alpine Country Club replaced the dishwasher and received a satisfactory. No food preps for the schools till September. Demarest Swim Club, waiting for paperwork to be submitted. No issues with the dog bite from January. Dog was licensed. 77 Pine Terrace is in the process of getting cleaned up. Mosquito Control was contacted, and the property was treated.

Board Secretary's Report:

Board Secretary reported that to date 444 Animal Licenses were issued. Late fees were extended to from March 1, 2021, to April 1,2021. Some pet owners were having issues getting appointments with their veterinarian. 4 Marriage Licenses were issued since the start of the year.
